

INTRODUCTION

The East Kazakhstan is one of the leading industrial and agrarian regions of the country with a huge industrial potential. Large enterprises of nonferrous metallurgy, machine building, energy, food and light industries are concentrated here. Unique beryllium, tantalum production sites'-and the world's largest plant for manufacturing fuel for nuclear power plants are located in this region. Investments in fixed assets are increased every year. Over the past five years, their volume has amounted to about 2.0 trillion tenge, including 436 billion tenge in 2017. Investment activity of the region is reflected in the State Program of Industrial and Innovative Development, which includes 70 investment projects for 892 billion tenge.

There were established Regional Council for Investment Promotion, Investor Service Branch, and an investment portal is functioning. To improve electricity supply, it is planned to implement renewable energy projects that will meet the increasing demand for electricity and reserve capacity. The East Kazakhstan is one of the most attractive regions for tourism, as its territory combines various types of natural resources, landscapes and historical and cultural sites, which allow developing almost all types of tourism.

Unique agricultural resources that successfully attract investors and investments are set here. The region develops public-private partnerships, attracting foreign investments through concession projects and the European Bank for Reconstruction and Development.

GUARANTEE OF INVESTOR RIGHTS PROTECTON

1) changes in the laws of the Republic of Kazakhstan and (or) entry into force and (or) changes of international agreements of the Republic of Kazakhstan which triggers change of procedures and conditions of import, manufacture and sale of excised goods;
 2) changes and additions into the laws of the Republic of Kazakhstan that are made to ensure national security, social order, health care and public morals. (point 3 article 276 EC RK) An investor may:

• 1) at its own discretion use incomes gained through the investing activity subject to payment of the taxes and mandatory payments into the budget pursuant to the laws of the Republic of Kazakhstan;

Investment activities shall mean activities of individuals and legal entities on contributing into the registered capital of commercial organizations or creating or increasing fixed assets used for the business activity and development of public private partnership projects (PPP project), inter alia a concession one. 

STATE IN-KIND GRANT

Content

Land plots, buildings, structures, machinery and computers, equipment, measuring and control devices and devices, vehicles (excluding motor vehicles), production and household equipment. The evaluation of state in-kind grants is carried out at their market value in accordance with the procedure established by the legislation of the Republic of Kazakhstan.

Amount

The value of a state in-kind grant is limited to 30% of investment amount in the fixed assets of a Kazakhstani legal entity.

The size (value) of the state inkind grant should be proved with the documents that must be attached to the application for investment preferences.
